Safety: Lab staff will bring with them on all trips a copy of this signed document and any medicine you have authorized the school to have on hand (through the "Medical/Allergy/Seizure Action Plan" you have filed with the school).

Advance Notice: Lab’s policy is to inform parents of field trips and other trips outside the building through SeeSaw, the master calendar, emails, green folders and/or the weekly newsletter. We strive to provide initial notification at least two weeks in advance.

- A. I understand that there are potential risks associated with all activities and I consent to my child’s participation in all activities.
- B. I understand that as a parent, if I believe it is necessary to limit my child's activity to a great extent, then the school may not be able to accommodate my child on this trip and that I and my child will be informed of this decision as soon as possible upon the receipt by the school of this completed consent form.
- C. I agree that in the event of an emergency injury or illness, the staff member(s) in charge of the trip may act on my behalf and at my expense in obtaining medical treatment for my child.
- D. I understand that payment is expected and not attending a trip is not cause for a refund.
- E. I understand that my child is expected to behave responsibly and to follow the school’s discipline code and policies.
- F. I agree and understand that I am responsible for the actions of my child, and I release the school from all claims and liabilities that arise in connection with the trip, except if due to the negligence of school officials.
- G. I understand that I am responsible for getting my child to and from the departure and return sites identified above. I understand that my child shall be accompanied by staff member(s) during the trip, including while traveling from the departure site to the destination site, and from the destination site to the return site.
- H. I understand that students who violate the school's discipline code may be excluded in the future by the school from participating in a trip.
